DIRECTION

SOLAR GOLD Gellable Tar Remover can be used straight or diluted with 4 parts product to 1 part water. With this dilution, **United 696** forms a sprayable gel, which is ideal for use on vertical surfaces. A thicker gel is produced when water is added to product, instead of product to water. Shake or stir vigorously. For best results, spray on surface using a pump-up sprayer or a trigger sprayer. Let product work and then rinse completely.

Do not allow the **SOLAR GOLD** to dry on the surface, but hose away with water after it has dissolved the tar and other soil. If used according to directions, **SOLAR GOLD**, will not streak painted surfaces in good condition. Heavy encrustations may require a second application.
