**GENERAL INFORMATION:**

**United 266 Earth Smart® Chiller Coil Cleaner** utilizes a high foaming formulation for cleaning chiller and evaporator coils of efficiency robbing particles. Because **United 266** "rinses automatically" with the natural condensation action on these coils, it can be used to clean coils in place with no messy rinse.

**United 266 is:**

- Bio-based – Formulated with surfactants on the EPA's Cleangredients list.

**DIRECTIONS FOR USE:**

1. Dilute one part **United 266** with three parts water and spray directly into finned coils making certain **United 266** penetrates to all areas. United's A199 Stainless Steel Atomizer, A042 2 Gallon Compression Sprayer, or A078 Foamatic Trigger Sprayer are recommended to apply **United 266**.
2. Put unit back into service to create condensation on chiller coils and fins which will carry **United 266** and dissolved soils down into condensation pan and drain. For faster cleaning, **United 266** may be rinsed if desired, after allowing at least five minutes penetration of soils and binders on coils and fins.

For cleaning of permanent-type filters, use one part **United 266** and three parts water in dip tank. After cleaning, rinse filters in clear water. For use as a filter adhesive, dip or spray undiluted **United 266** onto filter. **United 266** protects metal frames as well as filters by preventing corrosion.
