Just hand broadcast over the area where odors occur at the rate of 1/2 to 1 pound per 100 square feet. **United 201** gives effective, long lasting deodorizing control.

Use **United 201**...in **INSECT BREEDING REFUSE** and **GARBAGE CONTAINERS**. Before and after filling, sprinkle liberally. Repeat applications as necessary.

Use **United 201**...for general refreshing of **AREAS TO BE SWEPT**, by mixing the **United 201** granules in with the sweeping compound and sweeping normally.

Use **United 201**...to pick up **SPILLED LIQUIDS** and other **PROBLEM SPILLS**. It will absorb moisture and oil spills.
