DIRECTIONS FOR USE:

DRAINS: Depending on drain size, add 3 to 5 ounces of product to create a layer across the top of the fluid in the drain. Re-application will vary depending on drain flow. Replace when layer is noticeably deteriorated or odors begin to return.
