DIRECTIONS

For maximum effectiveness, **SOLAR GOLD Floor Drain Treatment** should be used as part of a regularly scheduled drain treatment program.

To treat a typical 4-inch diameter floor drain, first fill the drain with water. Then, slowly pour one pint (16 ounces) into drain. It is best to treat at the end of the workday when flow is at a minimum. Recharge monthly or after large flow with 8 ounces of product.

To test for the presence of drain flies, cover the drain opening with plastic wrap. Within 48 hours, larvae will appear on the plastic if the drain is infested.

To treat a sump, slowly pour in enough **SOLAR GOLD Floor Drain Treatment** to provide a one-inch layer. To roughly determine how much product to use, multiply the width of the sump by the length and divide by 2. That will give you the amount of product to use in gallons.

SOLAR GOLD will harm some plastics, rubber, neoprene and other soft materials.

When using a metering pump with this product, you must use Viton® tubing.
