**DIRECTIONS FOR USE:**

USE ACCORDING TO LABEL INSTRUCTIONS.

**For Controlling Fruit Flies:**

Spray **United 141** into and around the entire interior surface of drain, which will coat food source of fruit flies and eliminate them as they make contact. Treat at regular intervals to prevent further infestation.

**For Indoor/Outdoor Applications:**

Thoroughly apply **United 141** to all visible insects to ensure a rapid kill. Make sure all insects receive a thorough coating of **United 141**. Resilient insects may require additional treatments of **United 141**.

**Note:** **United 141** may make floor surfaces slippery. Use a mild detergent/water solution to clean **United 141** from floor surfaces.

**For Crack/Crevise Treatment:**

The product has demonstrated residual activity on certain crawling insects. Using the applicator tip, spray **United 141** into all cracks and crevices where insects may be hiding or nesting.

**United 141** may stain or alter the appearances of substrates including but not limited to baseboards, drywall, painted surfaces and concrete. May also stain carpet or fabrics. Test in an inconspicuous area first. To minimize staining, wipe away excess with an absorbent cloth and mild detergent/water solution.
