DIRECTIONS FOR USE:

USE ACCORDING TO LABEL INSTRUCTIONS.

For Controlling Midge and Filter Flies:

Using a bottle with a trigger sprayer or United's A037 One Gallon Compression Sprayer, spray **United 841** as a light mist into the air where the flies swarm. This will kill them on contact. Spray on side walls of facility to kill on contact and provide residual protection.

For Indoor/Outdoor Applications:

Thoroughly apply **United 841** to all visible insects to ensure a rapid kill. Make sure all insects receive a thorough coating of **United 841**. Some resilient insects may require additional treatments of **United 841**.

The product has demonstrated residual activity with midge flies, filter flies and certain crawling insects. Thoroughly apply **United 841** into cracks and crevices where insects may be hiding or nesting for extended protection.

Precautions: United 841 may make floor surfaces slippery. Use a mild detergent/water solution to clean **United 841** from floor surfaces.

United 841 may stain or alter the appearances of substrates including but not limited to baseboards, drywall, painted surfaces and concrete. May also stain carpet or fabrics. Test in an inconspicuous area first. To minimize staining, wipe away excess with an absorbent cloth and mild detergent/water solution.
