- Designed to remove inorganic (mud), or organic (sanitary sewage) and sludge deposits from storm and sanitary sewers.

DIRECTIONS FOR USE:

Manholes and Mains: In manhole, one or two MUD MONSTER blocks (depending on flow) should be placed in the U channel nearly vertically on the upstream end of the U channel.

It is recommended that mains be flushed periodically to remove the mud and silt freed by the use of **United 986 MUD MONSTER**.

Lift Stations: MUD MONSTER block should be used in low flow applications. Suspend the block so the entire block is submerged below the water at its lowest level. Apply one block for every 50,000 GPD flow. For flows in excess of 100,000 GPD, please contact your United Representative.

DIRECTIONS FOR USE: (continued)

Sumps: MUD MONSTER should be suspended in the sump so the block is just under the surface. Apply one 2 lb. block for every 350 gallons capacity. If capacity is over 350 gallons, spread the blocks out in different sections of the sump.

CAUTION:

Surfaces which have come in contact with a liquid solution containing **MUD MONSTER** may become extremely slippery. In those situations, apply United 961 Non-Ammoniated Polymer Solvent to remove spill.

EMERGENCY AND FIRST AID PROCEDURES:

EYES: Flush eyes with cool water for at least 15 minutes while keeping eyelids open. If irritation persists, seek medical attention.

SKIN: Wash with soap and water. Launder clothing. If irritation or redness persists, seek medical attention.

INHALATION: Not applicable.

IF SWALLOWED: Thoroughly rinse mouth with water. Drink one or two glasses of water. Slight gastrointestinal discomfort may occur.
