DIRECTIONS:

Pull towel from the container and wet the marked area. Begin removing marks by moving towel in a circular wiping motion. If heavy build-up exists, reapply and continue wiping until marks are removed. Removing some paints may require longer contact time. May not be as effective on marks that have been on surface for an extended period of time. Use caution when removing graffiti from a painted surface. Try product in a small, inconspicuous area to make sure paint is not removed along with graffiti.

After area is cleaned with **SMART SOLVE®**, use a clean, damp cloth to wipe away any remaining dirt or product.

Safe for use on any metal surfaces and many other hard, non-porous surfaces. May be used on fiberglass, Plexiglas and many plastic surfaces, but it is recommended to limit contact time to 10 minutes. Do not use on hard, clear polystyrene surfaces. This product may soften or craze certain plastics. If surface compatibility is uncertain, test in a small inconspicuous area before use. Do not use on asphalt surfaces.

DIRECTIONS FOR DISPENSING:

Remove lid. Pull towels up from the center of the roll and twist into a point. Push twisted towel through center of notched opening in the underside of the lid. Replace lid, making sure lid fits securely. Pull out wipe at a 90 degree angle and tear off at perforation. Dispose of properly. Remaining wipes feed automatically for next use. Always reseal hinged cap to insure against moisture loss and contamination.



HANDLING AND STORAGE: Keep container tightly closed when not in use. Store in a cool, dry, area and prevent from freezing. Allow to sit at room temperature before using product to ensure best product performance.

PRECAUTIONS: Avoid contact with eyes. Do not ingest.

EMERGENCY AND FIRST AID PROCEDURES:

EYES: Immediately flush eyes with water for at least 15 minutes while holding eyelids open. If irritation persists, get medical attention.

SKIN: Wash with soap and plenty of water. If symptoms develop, seek medical attention.

INHALATION: Remove to fresh air. If symptoms develop, seek medical attention. If not breathing, give artificial respiration.
