## **DIRECTIONS FOR USE:**

Idle Hot or Chilled Water Loops: Drain and thoroughly flush old water. Refill system with fresh water adding one gallon of **United 315** for each 500 gallons (1 litre for each 500 litres) of system capacity. Circulate briefly to mix uniformly.

**Sprinkler Systems:** Meter one gallon of **United 315** into the system for every 500 gallons (1 litre for every 500 litres) of system capacity. **United 315** does not accelerate combustion under any conditions.

Cooling Towers: Cooling towers in idle storage may be protected against corrosion by circulating one gallon of **United 315** for every 500 gallons (1 litre for every 500 litres) of system capacity for 24 hours before draining the system. DO NOT allow **United 315** to concentrate, as a silicate buildup may result.

Fire Departments: United 315 may be used in tanker trucks and other equipment where fire-fighting water is stored. Add United 315 at one gallon per 500 gallons (1 litre per 500 litres) of tank capacity. Circulate if possible to assure uniform mixing.
